It would be a good tool to use at Department Conventions or even a Detachment meeting during the year as there is a lot of useful information included in the presentation.

National Chaplain Howard Schaffer, presented the story of the Four Chaplains and there trip on the Dorchester.

The final Presentation was **from Dr. David Ulbrich from Norwich University**, **on the Battle of Cuzco Wells Cuba**. The battle took place in 1898 during the Spanish American War. The sinking of the Battleship Maine started the war. Sgt/Maj redirected fire from the USS Dolphin at Cuzco Wells. 300/400 Marines were up against 600/700 Spaniards George Elliott and Wendel Neville, both fought at Cuzco Wells and later became Commandants of the Marine Corps. The Marines lost 300 men in the battle.


